### **Bookings / Rules / Surcharges**

The church requires a minimum of **ONE** month's notice with full payment for church wedding flowers.

All floral arrangements are not to be removed from the church premises after the wedding. Please approach the Floral Ministry Coordinator if you have any enquiries.

There will be a **20% surcharge** on floral packages for weddings held during the following period due to the increase in cost of flowers during these times:

- 26<sup>th</sup> December to 28<sup>th</sup>/29<sup>th</sup> February or day before Ash Wednesday – whichever is earlier
- Day after Easter to end of May
